LOCATION: Rattlesnake Mountain Shooting Facility, 10 miles Northwest of Richland, WA. Access to the range is through the High Power / Shotgun Gate, located at MP 8.5, North of I-82 (Benton City), or 3 Miles South of Hwy 240, on Hwy 225. Map available at: http://www.tcsa.info/directions.

RULES: These are not NRA Approved / Registered matches, but they will generally follow current NRA High Power rules. Eye and hearing protection are required.

ELIGIBILITY: Open to all competitors. Scores will be tracked & tallied by the generally recognized NRA disciplines of Sling, F-Open & F-TR.

EQUIPMENT and AMMUNITION: Any safe rifle may participate. At the sole discretion of the Match Director, unsafe or inaccurate rifles / competitors will be removed from the match.

As matches will be fired on ShotMarker electronic targets, shooters will need to bring a Wi-Fi enabled device (phone/tablet).

Any safe ammunition may be used, except the use of tracer, incendiary, or armor piercing ammunition is prohibited. Fired rounds that fail to reach the target at supersonic velocity and/or fail to impact the target berm will cause the competitor to be removed from the firing line.

INDIVIDUAL ENTRY REQUIREMENTS: Email (<u>jlhauptmann@gmail.com</u>) or text (509-308-9230) match director prior to the match with intent to participate.

ENTRY FEE: \$20 per day for the match, payable at the range on the day of match. Junior competitors are half price.

ENTRY LIMIT: Forty (40) individual shooters total.

TARGETS & TARGET SERVICE:

Match will be fired on ShotMarker electronic targets with discipline appropriate NRA MR-1 or MR-1FC paper target faces.

SCORING: Competitors will score for the other shooters on their relay.

EMPTY CHAMBER INDICATOR (ECI): Required to be used at all times prior to match preparation time and after firing is complete.

SQUADDING: All matches will be squadded.

REPORTING OF SCORES: Scores will be tallied, and top scores announced at the end of the match. Scores WILL NOT be reported to the NRA.

COURSE OF FIRE

600 Yard Match - Prone Slow fire

- String # 1 Unlimited sighters and 20 shots for record from 600 yards, time limit of 22 minutes.
- String # 2 Unlimited sighters and 20 shots for record from 600 yards, time limit of 22 minutes.
- String # 3 Unlimited sighters and 20 shots for record from 600 yards, time limit of 22 minutes.

Long Range Practice - Prone Slow fire

There will be an opportunity to practice at long range (1000 yards) following the 600 yard match.

OTHER DETAILS:

<u>Sustenance & Weather:</u> Rattlesnake is a primitive & barren range. Bring your own WATER and food. No organized lunch break will be taken. Plan for inclement weather (i.e., heat, cold, sun, rain, & wind). **There is no shade or shelter on the High Power range, so plan accordingly.**

<u>Accommodations:</u> There are NO WATER or ELECTRICAL hook-ups available on the range. Portable toilets are available. Nearby (2 miles) is the Horn Rapids County Park on the Yakima River. It has full RV hook-up and no hook-up sites at moderate cost. No reservation system is in place at this time. Other accommodations may be found nearby in Richland (10 mi.), restaurants and groceries in Benton City (6 mi.)

<u>Airport:</u> The Tri-Cities airport is located in Pasco (PSC). It is 20 miles from the range, and is served by Alaska, Allegiant, American, Delta and United airlines.
